With reference to the above subject, under above cited letter reference(1), the above said proposal is submitted to the Regional Officer (SE-RO), Ministry of Road Transport & Highways Bengaluru for approval. But proposal is returned with some observations vide above cited reference (2).

Hence, the proposal is resubmitted with compliance to the observations raised by your kind self vide reference (2) is as below,

SI.No.	Observations	Compliance.
1	In the cross sectional drawings crossing at Ch.12.230, 14.380, 15.735 & 16.580 of NH-548B the difference between road level (Top of subgrade) and casing pipe is less than 1.2 mtr. As per the Ministry's guideline the minimum distance between the top of subgrade & top of casing pipe should be 1.2mtr.	the Ministry's, the minimum cushion of 1.20 mtr is maintained and the same is incorporated

SI.No.	Observations	Compliance.
2	Observations The pipe should be with the NP-4 casing and the same needs to be shown in the drawings. Which should be duly certified by EE.NH.Division, Vijayapur needs to be submitted.	Noted Sir, NP-4 casing pipe is considered and same is also shown in enclosed drawing
3	As per the Ministry's Guidelines the overfilling and site filling should be of granular material in layers not graterthan 15cm in each layer. However, in cross section drawing earth filling is shown which needs to be corrected.	Noted Sir, the over filling and side filling granular material is considered and it will be executed as per MOR&TH specification and is also incorporated in drawing.
4	In the check list it is mentioned that, the ROW varies from 25m to 27m. However, in the license fees calculation the ROW taken as 22mtr which is not as per the check list. Also there is no signature of competent authority in license fee calculations. The license fees calculations needs to be submit as per ROW.	Now the license fee is calculated 27 m for ROW as per the site condition and duly signed by the competent Authority is enclosed.
5	The agreement is to be made between the Regional Officer, MORT&H Bengaluru (Authority) and the Executive Engineer, KNNL, HBC Divisiion, Athani leaving Date/Month/Year blank without any typograhical erros along with witness signature.	Noted Sir, corrected fresh agreement bond is resubmitted.
6 EUA OM	All the particulars of the check list including methodology of crossing the NH needs to be verified and certified by field authority i.e. Executive Engineer, NH.Division, Vijayapur.	Noted Sir, verified and certified the same.





Typical crossing section of open trenching method for water pipeline at chainage 15.735 of pipe dia 900mm






