Invitation of Public Comments

Sub: NHAI, RO Chennai - PIU - Salem - Proposal for Laying of Water Pipe Line Along the road from Km 59/300 to Km 84/600 (LHS) of NH-544 (Komarapalayam - Chengapalli Section) for the total length of 25.3 Km by the M/s State Industries Promotion Corporation of Tamilnadu Ltd, Erode.

- 1. The subject proposal is requesting permission for 600mm Dia Water Pipeline along the utility corridor from Km 59/300 to 84/600 (LHS) by Open Trench Method for a length of 25.3 Km along the road 1.85m depth below the ground level by open cut method in the Project highway of (Kumarapalayam to Chengapalli section) of NH-544 in the State of Tamilnadu..
- 2. The available width of ROW is 60m (30 + 30) and it is proposed to lay the pipeline in the utility corridor.
- 2. M/s. State Industries Promotion Corporation of Tamilnadu Ltd, Erode has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R (R) dated 22.11.2016, the proposal submitted by M/s. State Industries Promotion Corporation of Tamilnadu Ltd, Erode will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
