Invitation of Public Comments

Sub: NHAI, RO Chennai – PIU – Salem – Permission for laying of a Public Utility – "City Gas Distribution (CGD)" Carbon Steel and MDPE Pipeline with OFC along NH-544 (Sri Nagar – Kanyakumari) in between highway Chainage Km 205/300 to Km 207/650 (LHS) for a total length of 2350m in the limits of National Highways by M/s. Indian Oil Corporation Limited, Salem – Regarding

- 1. The subject proposal pertains to a proposal requesting permission for laying of RLNG pipeline, of public utility "City Gas Distribution (CGD)" Carbon Steel of 219mm dia and MDPE Pipeline of 125mm dia with OFC of 40mm dia along NH-47 on (Sri Nagar Kanyakumari Highway) for a length of 2350m. The available width of ROW varies from 21-11m to 21-11m. And, it is proposed to lay the pipes and OFC on the utility corridor for a length of 2350m in LHS from Km 205/300 to Km 207/650.
- 2. DGM (PJ-CGD), M/s. IOCL, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by DGM (PJ-CGD), M/s. IOCL, Salem will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
