Accordingly the following compliance to the observation are submitted by the Assistant Executive Engineer, National Highway Sub Division, Mangalore vide letter cited under ref (3).

1	The laying of water pipeline is proposed on both side of NH. The proposal needs to be examined in light of future widening to 2 lane + Paved shoulder and 4 laning for which the entire available land in ROW is required. Further, corridor of impact of widening work w.r.t. the available ROW may also be examined.	Now the laying of water pipeline is proposed on one side of National Highway. Resubmitted modified all drawings, check list etc.
2	The proposed work becomes a obstruction for the widening of NH road in near future. This will hamper future improvement of National Highway. Hence, lying of pipeline on alternate route or in single side of National Highway may be explored.	proposed on one side of National Highway.
3.	In the enclosed proposal, the chainages mentioned in the proposed drawings and in the license fee calculation is not matching and for calculation of license fee all the proposed pipelines needs to be considered. As such the Executive Engineer, National Highway Division, Mangalore is requested to examine the proposals thoroughly as per Ministry's guidelines and see that the proposal is properly prepared in the file format and submitted to this office, to avoid delay in processing the proposals.	and license fee calculation is now corrected and resubmitted by the KUID & FCL, Puttur Division. The license fees calculation sheet and BG calculation sheets are enclosed in Annexure - I and Annexure - II. The proposal is verified and herewith submitted.
