The same was returned by the Regional Officer with observation vide letter cited under reference(2) . The Compliance received from the AEE NH Sub Division Mysore is here with submitted as under .

Sl. No	Observation	Compliance
1	As the work of Rectification of Block spot is being taken up by the NHAI at the proposed location, the recommendation of NHAI needs to be submitted. The Proposal along with the Proposed drawings needs to be examined and to be certified by Project director NHAI Mysuru.	Concurrence has been taken by NHAI ,the stretch from km 181.120 to 182.220 is handed over to NHAI for improvement of Blackspot i.e Construction of an under pass and the work is under progress. Accordingly, NHAI Authorities has suggested the feasible location for crossing pipeline i.e at km 182.060 of NH-275 with top level casing should be minimum of 3.5 M below the Existing road level by adopting HDD Method .

Further as suggested by NHAI, Executive Engineer CNNL Hunsur has modified and resubmitted the Proposal .

The revised proposal received from AEE NH Sub Division Mysuru is here with submitted for obtaining permission. It is requested to consider the proposal as the same involves larger public interest.
