

5	Provision of Casing Pipe for road crossing in the proposal is to be mentioned clearly and same needs to be adopted for the calculation of licence fee.	MS Casing Pipe of 2.6 m Dia for encasing 2.3m Dia MS Pipe is provided at chainage Km 268+370. MS Casing pipe of 0.45m Dia for encasing 0.18 m Dia HDPE Pipe is provided at Ch. Km 269+000. And Licence fee is calculated for the same.
6	All pages of check list need to be verified & to be certified by the Executive Engineer.	All pages of Check list are verified and certified.
7	The proposal needs to be examined/recommended in light of any improvement work sanctioned/proposed in the above said stretch.	The proposed stretch is not subjected to any near future improvements.
