Invitation of public comments

Sub: Proposal for grant of access permission to a new fuel station of M/s. Nayara Energy Limited (Formaly known as Eassar Oil Limited) in the Km CH. 79/520 to 79/555 (RHS) on NH-162E in Khasra No. 1087/18 & 1139/1087/18 of Village-Sangath, Taluka-Badgaon & District- Udaipur in the state of Rajasthan -Regarding Final NOC

M/s. Nayara Energy Limited ie. The applicant vide letter no. EOL/RJ280218288382/SANGATH/2019/NH#01 dated 03.04.2019 has submitted a proposal to this office on above mentioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/NH-33023/19/99-DO.III dated 24.07.2013 as construction of retail outlet completed only after approximately 2 years and 6 month from the date of issuance of provisional NOC, thus violating the Ministry Guidelines. The applicant also submitted that DM NOC from DM Udaipur was received only after 2 years from the date of issuance of provisional NOC from this office. Thereby the applicant has submitted proposal for time extension and relaxation for above mentioned proposal.

- 2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.
- 3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in)
- 4.0 This is issued with the approval of Highway Administration-cum Regional Officer, MoRTH, Jaipur.
