Invitation of Public Comments

Sub: NHAI, RO Chennai – PIU – Coimbatore –6-laning from Km 102.035 to Km 144.680 on the Chengapalli to start of Coimbatore Bypass and 4-laning from Km 170.880 to Km 183.010 on end of Coimbatore bypass to TN/Kerala Boarder section of NH-47 (New No.NH-544) – Proposal for laying of underground water pipeline from Km 119/690 to Km 120/000 (LHS & RHS) and Road crossing by HDD method at Km 119/630, for a length of 620 m in Chengapalli to Walayar section of NH-47 - in the limit of National Highways by M/s. TWAD Board, Tiruppur– Regarding

- 1. The subject proposal is requesting permission for laying of Underground 500mm Dia Water pipeline along the utility corridor from Km 119/690 to 120/000 BHS by Trench Method for a length of 620 m along the road and one number Road Crossing at Km 119/690 of minimum 1.65m depth below the ground level by HDD method in the Project highway of Chengapalli to Walayar section of NH-544 in the State of Tamil Nadu.
- 2. The available width of ROW is 60 m (30 + 30) and it is proposed to lay the pipeline in the utility corridor and one number road crossing
- 3. M/s. TWAD Board, Tiruppur has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. TWAD Board, Tiruppur will be made available for 30 days seeking public comments/objection. and shall be furnished within 30 days from the day of closure of public objections.
