Sub: NHAI, Madurai Region - PIU, Dindigul - Permission for erection of 33 KV Over Head line EB Pole along the road from Km 324/675 to Km 325/000 on LHS & across NH at Km 325/000 in Karur - Dindigul section of NH-44 in the State of Tamil Nadu - Proposal submitted - Reg.

The proposal received from PD, Dindigul vide letter No. NHAI/PIU/DGL/11014/08/OHL/Erection/2022/771 dated 01.04.2022 thereby requesting permission for erection of 33 KV Over Head line EB Pole along the road from Km 324/675 to Km 325/000 on LHS & across NH at Km 325/000 in Karur - Dindigul section of NH-44 in the State of Tamil Nadu proposed by the Managing Director, M/s Vinoba Green Energy Pvt Ltd., Karur in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by the Managing Director, M/s Vinoba Green Energy Pvt Ltd., Karur requesting permission for erection of 33 KV Over Head line EB Pole along the road from Km 324/675 to Km 325/000 on LHS & across NH at Km 325/000 in Karur - Dindigul section of NH-44 in the State of Tamil Nadu as detailed under;

3) As mentioned in the proposal, the ROW is 60 m @ Km 325/000 i.e. 30 m on LHS and 30 m on RHS from the centreline. As observed from the drawing, the EB Poles are to be erected along NH from Km 324/675 to Km 325/000 at a distance of 28m from the centerline on RHS & 2 Nos. of EB Poles are proposed to be erected across NH at Km 325/000 i.e. at a distance of 28m from the Centerline on BHS.

- 4) In this instant proposal, the proposed Vertical Clearance is 10 m which is satisfying the MoRTH Specifications.
- 5) The Managing Director, M/s Vinoba Green Energy Pvt Ltd., Karur has furnished necessary undertaking to the effect that they will relocate the Over Head line EB Poles as and when requested by the NHAI at their own cost. It is also mentioned that, the proposed erection of 33 KV Over Head line EB Poles along & across NH work will not to damage any other utility, if damaged they will pay the losses either to NHAI or to the concerned agency as per Ministry Guidelines dated 22.11.2016.
- 6) Accordingly, the proposal is in conformity with Policy Guidelines issued by Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016. Also, as per the above mentioned Policy Guidelines, the application is made on public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
