The proposal is regarding Permission for erection of 22 KV Over Head Power Transmission line along NH from Km 3/150 to Km 5/950 in the section of Dindigul - Theni of NH-45(E) in the State of Tamil Nadu submitted to this office by PD, PIU Dindigul vide letter No. NHAI/PIU/DGL/11014/08/ TNEB/Erection/2020/1954 dated 05.11.2020 & modified proposal vide Letter No. NHAI/PIU/DGL/ 11014/08/TNEB/ Erection/2020/2311 dated 18.12.2020 in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment proposed by the Authorized Signatory, M/s. Talco-Dindigul Tanners Enviro Control Systems Pvt Ltd for erection of 22 KV Over Head Power Transmission line along NH from Km 3/150 to Km 5/950 in the section of Dindigul - Theni of NH-45(E) in the State of Tamil Nadu i.e. in a length of 2818 m as detailed under:

3. The Right of Way from Km 3/150 to Km 5/100 & from Km 5/300 to Km 5/950 is 30 m and the Right of Way from Km 5/100 to Km 5/300 is 45m in the aforesaid stretch. Accordingly, The Authorized Signatory, M/s. TALCO Dindigul Tanners Enviro Control Systems Pvt Ltd has proposed to erection of 22 KV Over Head Power Transmission line along NH from Km 3/150 to Km 5/950 for a length of 2818 m at the extreme edge of the afore-mentioned ROW.
4. The Authorized Signatory, M/s. TALCO Dindigul Tanners Enviro Control Systems Pvt Ltd has furnished necessary undertaking to the effect that they will remove the erection of 22 KV Over Head Power Transmission line along NH in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed erection of 22 KV Over Head Power Transmission line along NH work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
