Sub: NHAI, Madurai Region - PIU, Dindigul - Permission for the proposal of laying of Water Supply Pipeline along the road in existing NH-209 from Km 85/350 to Km 85/835 (LHS) & across NH at Km 85/835, along proposed spur road-I from Km 1/058 to Km 4/656 (LHS), along the proposed NH-209 road from Km 84/518 to Km 89/000 (LHS) & across NH at Km 89/000 in Madathukulam - Pollachi Section of NH-209 (New NH-83) in the State of Tamil Nadu - Proposal submitted - Reg.

The proposal regarding permission for laying of Water Supply Pipeline along the road in existing NH-209 from Km 85/350 to Km 85/835 (LHS) & across NH at Km 85/835, along proposed spur road-I from Km 1/058 to Km 4/656 (LHS), along the proposed NH-209 road from Km 84/518 to Km 89/000 (LHS) & across NH at Km 89/000 in Madathukulam - Pollachi Section of NH-209 (New NH-83) in the State of Tamil Nadu was submitted to this office by PD, PIU, Dindigul vide letter No. NHAI/PIU/DGL/11014/DP/NH-209/Pck-III/2021/2519 dated 31.12.2021 (Received on 06.01.2022) in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by the applicant i.e. Smt. M. Arulselvi, Periyakottai for laying of water supply pipeline along the road in existing NH-209 from Km 85/350 to Km 85/835 (LHS) & across NH at Km 85/835, along proposed spur road-I from Km 1/058 to Km 4/656 (LHS), along the proposed NH-209 road from Km 84/518 to Km 89/000 (LHS) & across NH at Km 89/000 in Madathukulam - Pollachi Section of NH-209 (New NH-83) in the State of Tamil Nadu as detailed under:

3) The Right of Way is 37 m in Old NH-209, 60m in New NH-209 road & 60m in spur road-I. The applicant i.e. Smt. M. Arulselvi, Periyakottai has proposed to lay Water Supply Pipeline along the road in existing NH-209 from Km 85/350 to Km 85/835 (LHS) & across NH at Km 85/835, along proposed spur road-I from Km 1/058 to Km 4/656 (LHS), along the proposed NH-209 road from Km 84/518 to Km 89/000 (LHS) & across NH at Km 89/000 in Madathukulam - Pollachi Section of NH-209 (New NH-83) in the State of Tamil Nadu. Further, the applicant has given undertaking that the proposed Water Supply Pipeline will be laid along NH by **Open Trench Method** (from Km 85/350 to Km 85/835 (LHS) in existing NH-209, from Km 1/058 to Km 4/656 (LHS) in proposed spur road-I & from Km 84/518 to Km 89/000 (LHS) in proposed NH-209 road) at a depth of 1.20 m from the ground level & across NH through **HDD Method** (At Km 85/835 in existing NH-209 & Km 89/000 in proposed NH-209) at a depth of 1.20 m to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.

4) The applicant i.e. Smt. M. Arulselvi, Periyakottai has furnished an undertaking to the effect that they will shift the laid water supply pipeline as and when required by NHAI at their own cost. Also, certified that, the proposed laying of water supply

pipeline work will not to damage any other utility, if damaged, they will pay the losses either to NHAI or to the concerned agency.

5) As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant will be made available for Public comments and the comments will be invited within 30 days from the day of uploading.
