Sub: NHAI, Madurai Region - PIU, Nagercoil - Permission for laying of water supply pipeline along NH from Km. 71/750 to Km 72/300 (RHS) of NH-47 for providing CWSS to Eraniel TP & 319 rural habitations & Improvements to Padmanathapuram CWSS and Kattathurai CWSS in Kanyakumari District - Reg

The proposal is regarding permission for laying water supply pipeline along NH from Km 71/750 to Km 72/300 (RHS) of NH-47 in the State of Tamil Nadu submitted to this office by PD, PIU Nagercoil vide letter No, NHAI/PIU/NGL/NH-47/NOC/2020/853 dated 07.08.2020 and PD-Nagercoil letter dated 02.02.2021 in accordance with Ministry's latest guidelines dated 22.11.2016.

2. The alignment proposed by the Executive Engineer, TWAD Board, Project Division, Nagercoil for laying water supply pipeline along NH from Km 71/750 to Km 72/300 (RHS) of NH-47 in the State of Tamil Nadu i.e. in a length of 550m as detailed under:

- 3. The Right of Way is 60 m in the aforesaid stretch. The Executive Engineer, TWAD Board, Project Division, Nagercoil has proposed to lay water supply pipeline along NH from Km 71/750 to Km 72/300 in NH-47 for a length of 550 m at the extreme edge of ROW (i.e. Utility Corridor). Further, the Executive Officer, TWAD Board, Project Division, Nagercoil has given undertaking that the lay of supply pipeline is proposed to lay by *Open Trench Method* at a depth of 1.70 m distance to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.
- 4. The Executive Officer, TWAD Board, Project Division, Nagercoil has furnished an undertaking to the effect that they will remove the laid of water supply pipeline in future if required by NH Authority at any time for expansion of the NH at their own cost without claiming any compensation from NHAI. Also, certified that, the proposed laying of water supply pipeline work will not affect

the design, stability, traffic safety and future improvement of the proposed stretch.
