Further, the Executive Engineer, TWAD Board, RWS Division, Nagercoil has given undertaking that the lay of supply pipeline is proposed to lay by Open Trench Method (Km 602/020 to Km 602/150, Km 602/150 to 603/580, Km 603/580 to Km 603/730, Km 604/860 to 607/300 (LHS) & Km 602/030 to Km 603/730, Km 604/530 to Km 604/880, Km 606/300 to Km 607/300 (RHS)) & *HDD Method* (Km 602/150, Km 602/665, Km 603/630, Km 603/730, Km 604/860, Km 606/300, Km 606/965 and Km 607/300) at a depth of 2 m distance to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.

- 4) The Executive Engineer, TWAD Board, RWS Division, Nagercoil has furnished an undertaking to the effect that they will shift the laid Water Supply Pipeline in future if required by NHAI at their own cost. Also, certified that, the proposed laying of Water Supply Pipeline work will not to damage any other utility, if damaged, they will pay the losses either to NHAI or to the concerned agency.
- 5) As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29 /2015/S&R(R) dated 22.11.2016, the application submitted by the applicant is available for Public comments and the comments may be invited within 30 days from the day of uploading.
