Sub: NHAI, Madurai Region - PIU, Madurai - Four lane divided carriageway from Vadipatti (Design Chainage Km.0+000) to Thamaraipatti (Design Chainage Km.29+960) stretch of Madurai Ring Road section of NH-744A on EPC mode under Bharatmala Pariyojana Phase-I in the State of Tamil Nadu - Permission for laying of underground R-LNG pipeline of IOCL crossing at Km.28+875 in Thamaraipatti Village if Vadipatti to Thamaraipatti section of NH-744A - Proposal submitted - Reg.

The proposal is regarding permission for laying underground R-LNG pipeline across the road at Km.28+875 in Thamaraipatti Village of Vadipatti - Thamaraipatti section of NH-744A in the State of Tamil Nadu submitted to this office by PD, PIU, Madurai vide Lr.No. NHAI/PIU/MDU/NH-744A/Utility/2022/1973, dt.25.06.2022 in accordance with Ministry's latest guideline dated 22.11.2016.

2. The alignment proposed by the Deputy General Manager (Construction), M/s. Indian Oil Corporation Limited, Chennai for laying R-LNG pipeline across the road at Km.28+875 in Thamaraipatti Village of Vadipatti - Thamaraipatti section of NH-744A in the State of Tamil Nadu as detailed under;

3. The Right of Way is 60 m in the aforesaid stretch. The proposed laying of R-LNG pipeline crossing the road at Km.28+875 of Vadipatti - Thamaraipatti section of NH-744A. Further, the applicant M/s. Indian Oil Corporation Limited has given undertaking that the lay of R-LNG pipelines is proposed to lay by *HDD Method* at a depth of 1.7m distance to the casing pipe from the top of the sub grade which is in conformity with Ministry's latest guidelines dated 22.11.2016.
