Subject: Permission for laying underground Optical Fiber Cable along the NH in the section of Trichy-Dindigul of NH-45 from Km 420/400 to Km 420/700 (LHS) in the State of Tamil Nadu - Proposal Submitted - Reg.

The Proposal is regarding permission for laying underground Optical Fiber Cable along the NH in the section of Trichy-Dindigul of NH-45 from Km 420/400 to Km 420/700 (LHS) for a total length of 300m in the State of Tamil Nadu by M/s Jio Digital Fibre Private Limited, Chennai has submitted to this office by the PD, PIU, Trichy vide letter No. NHAI/PD/TRY/Utility/NH 45/T-D/OFC/2021/516 dated 01.04.2021 in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by M/s Jio Digital Fibre Private Limited, Chennai along the NH from Km 420/400 to Km 420/700 (LHS) of Trichy-Dindigul of NH-45 i.e. in a length of 300 m as detailed under:

3) The Right of Way is 60 m in the aforesaid stretch. M/s Jio Digital Fibre Private Limited, Chennai has proposed to lay the Optical Fiber Cable at the edge of the ROW for a length of 300 m along NH from Km 420/400 to Km 420/700 (LHS) of Trichy-Dindigul of NH-45 in the State of Tamil Nadu at a depth of 1.65 m from the bottom of the ground which is in conformity with Ministry's guidelines dated 22.11.2016.

4) M/s Jio Digital Fibre Private Limited, Chennai has furnished an undertaking to the effect that the applicant will remove the laid OFC line in future if required by NH wing of State Highways Department/MoRTH Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH Govt. of India and any right on the NH land. Further, mentioned that M/s Jio Digital Fibre Private Limited, Chennai will also restore the surfaces to its original condition soon after removal of the OFC lines.

5) As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the proposal submitted by the applicant will be made available for public comments and the comments may be invited within 30 days from the day of uploading.
