The Proposal is regarding permission for laying underground Optical Fiber Cable along the NH in the section of Ulundurpet -Padalur of NH-45 from Km 268/800 to Km 281/500 (RHS) for a length of 12.70 Km in the State of Tamil Nadu by M/s. Telesonic Networks Ltd, Chennai submitted to this office by the PD, PIU, Trichy vide letter No. NHAI/PD/TRY/Utility/NH-45/OFC/2020/865 dated 03.12.2020in accordance with Ministry's latest guidelines dated 22.11.2016.

2) The alignment proposed by M/s. Telesonic Networks Ltd, Chennai along the NH from Km 268/800 to Km 281/500 (RHS) of Ulundurpet -Padalur of NH-45 i.e. in a length of 12.70 Km as detailed under:

3) The Right of Way is 60 m in the aforesaid stretch. M/s. Telesonic Networks Ltd, Chennai has proposed to lay the Optical Fiber Cable at the edge of the ROW for a length of 12700 m along NH from Km 268/800 to Km 281/500 (RHS) of Ulundurpet -Padalur of NH-45 in the State of Tamil Nadu at a depth of 1.65m from the bottom of the ground which is in conformity with Ministry's guidelines dated 22.11.2016.

Further, mentioned that M/s. Telesonic Networks Ltd, Chennai will also restore the surfaces to its original condition soon after removal of the OFC lines. Also, certified that the proposed Optical Fiber Cable work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
