Subject:- Access permission and approval for new retail outlet of M/s BPCL, Surat abutting on NH-753 B at km 151+718 (between km 151+699 to km 151+738), right hand side of Block/ Survey No. 246 (old -124/45) at village Nivalda, Tal Dediapada & Dist. Narmada in the state of Gujarat.

Please refer to the oil company's letter dated 13.09.2019 for relaxation of the subject case.

- 2. The subject proposal was submitted on Ministry's website on 17.06.2019 and was sent vide this office letter dated 21.06.2019 to EE, NH Division, Bharuch for examination.
- 3. As per inspection report submitted by concerned EE, NH Division, Bharuch it is noted that the case is meeting all the parameters of the guidelines except for the criteria of NH/SH/MDR/City road which is at distance of 508 m against 1000 m. Looking to the feasibility of construction of service road at this location is very difficult due to obstruction in road side land at this location. Therefore, the Executive Engineer, NH Division, Bharuch vide his letter no PB/NOC/PP/2554 of 2019 dated 03.09.2019 advised to apply the case for relaxation as per MoRT&H Guidelines.

Further, the oil company vide letter dated 13.09.2019 has asked this office to consider case as per relaxation in guidelines for access permission along National Highway circulated vide letter no. RW/NH-33023/19/99-DOIII dated 16.03.16.

- 4. In view of the above, comments of public, (if any) on grounds of road safety and inconvenience to road user, on the above mentioned proposal is invited on below mentioned address/ Email address.

Inspection Report

Inspection report of the officer inspecting the site of Access Permission And Approval For New Retail Outlet Abutting On N.H.-753/B, Chain Age In Kilometer 151+718 (Between Km 151+699 To Km 151+738 Km) Right Hand Side, Block/Survey No. 246(Old-124/45), At Village: Nivalda, Tal.: Dediapada, Dist.: Narmada, State: Gujarat. and certificate for compliance of standard conditions.

This is to certify that I, Executive Engineer, N.H. Division, Bharuch have inspected the new Retail Outlet at chainage Chain Age In Kilometer 151+718 (Between Km 151+699 To Km 151+738 Km) Right Hand Side on NH-753/B.

Observations made as below:

- 1. This Fuel Station is located on Rural Reaches.
- 2. The National Highway 753/B is Un-divided highway.
- 3. The distance of the nearest rural road from proposed fuel station is 968m, minimum distance required is 300m, therefore satisfies the MoRTH norms and circular.
- 4. The distance of the nearest fuel station from proposed fuel station is 1100m, minimum distance for un-divided carriageway required is 300m, therefore satisfies the MoRTH norms and circular.
- 5. The general ground level of the proposed fuel station is 30 cms. below the level of the edge of the shoulder which is sufficient for adequate drainage.
- 6. The construction of proposed retail outlet has not commenced.
- 7. In this proposal of fuel station, the norms of minimum distance of the intersection from the road with NHs,SHs, minimum distance required is 1000.00 M, NH/SH/MDR/City Road is at 508 m for the subject location, so Proposed Retail Outelt has proposed 717m long 5.50m wide service road. But, looking to the feasibilty of construction of service road at this loction, it is very difficult to construct this service road of this length as there are obstructions in road side land at the location, so it is adviced to apply for Relaxation as per MoRTH Guidelines.

This is certified that the location of the Bharat Petroleum Corporation Ltd Retail Outlet conforms to all standard condition as mentioned in MoRT&H letter No. RW/NH-33023/19/99/D0-111,dtd 24/07/2013.

- 1. The proposal is meeting all the parameters of Ministry's guidelines except NH/SH/MDR/City Road i.e. at 508m against 1000m of the Ministry Guidelines. So, a service road has been proposed of 717.00m length and 5.50m width. But, as the land on which service road is being proposed belongs to reserve forest department and there are big trees on the path of service road so it's not feasible considering de-forestation. It is also difficult to take Forest N.O.C. from Forest Department.
- 2. Therefore you are requested to submit the case for relaxation in the light of Ministry latest guidelines/norms for relaxation in guidelines for access permission along National Highway circulated vide letter no. RW/NH-33023/19/99-DOIII dated 16.03.16.
- 3. In view of the above, it is humbly requested to upload the case on Ministry's website for comment of public as per Ministry's guidelines dated 16.03.16.
