Sub: Up-gradation of NH-127C from Samthaibari (Assam) to Gelephu (Indo-Bhutan Border) from existing Intermediate Lane to 2-Lane with Paved Shoulder – (Job No. 127C/AS/2024-25/268) – Request for generation of declaration under Section 3D of the NH Act, 1956.

Sir,

With reference to the subject cited above, I have the honour to inform you that the land acquisition proceedings for the project road NH-127C from Samthaibari (Assam) to Gelephu (Indo-Bhutan Border) have been initiated in accordance with the provisions of the National Highways Act, 1956.

The notification under Section 3A was initially published vide Gazette Notification No. S.O. 5238(E) dated 04.12.2024. However, the validity of the said notification lapsed on 03.12.2025. Subsequently, after due revalidation, the notification under Section 3A for the said land acquisition was published afresh vide Gazette Notification No. S.O. 5811(E) dated 16.12.2025.

As provided under the Act, the notification under Section 3A was also published in the concerned local newspapers for inviting objections, if any, from the affected persons. Accordingly, the stipulated objection period of 21 days has expired on 15.01.2026.

Further, CALA has informed that draft notification under 3D could not be generated in bhoomirashi portal due to some technical issues. i.e. only one survey number was showing in portal. However as per 3A it is 189 survey numbers (screenshot enclosed)

In view of the above, it is requested to kindly look in to the matter and take necessary action in this regard.
