Applicant may be required to submit certificates such as Statutory Auditor Certificates exactly as per Performa specified in the RFAQ, wherever otherwise. The Authority is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall be dealt with as per provisions of RFAQ/ Bidding Documents.
