Invitation of Public Comments

Sub: NHAI, RO Chennai - PIU - Salem - Proposal for providing water supply to advanced institute for integrated Research on Livestock and animal sciences, Thalaivasal V.Koot road in Salem District of NH-79 (Salem - Ulundurpet section) by crossing of 500mm dia DI pipe at Km 75/770 for a length of 58m by the Executive Engineer, TWAD Board, Salem - Approval Requested - Reg.

- 1. The subject proposal is requesting permission for 500mm Dia Water pipeline across the utility corridor at Km 75/770 and 1.2m depth below the ground level by HDD method in the Project highway of (Salem to Ulundurpet section) of NH-79 in the State of Tamil Nadu.
- 2. The available width of ROW is 60m (30 + 30) and it is proposed to lay the pipeline in the utility corridor.
- 3. The Executive Engineer, TWAD Board, Salem, has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, TWAD Board, Salem will be made available for 30 days seeking public comments/objection. and shall be furnished within 30 days from the day of closure of public objections.
