**Invitation of Public Comments**

Sub: NHAI, RO, Chennai - PIU, Coimbatore - Rehabilitation and up-gradation of NH-209 from Km 123/550 to Km 150/400 of Dindigul - Bangalore Road ( Pollachi to Coimbatore section) to four lane with paved shoulder in the state of Tamilnadu under NHDP-IV on EPC Basis - Proposal for crossing underground 22 KV electrical power cable (2 Nos. of 160mm dia HDPE pipe at Km 132/180 by HDD method in connection with Railway electrification of Pollachi - Podanur railway section in the limits of National Highways by M/s. L&T Constructions Limited - Approval Requested - Reg.

1. The proposal is regarding permission for Crossing underground 22 kv electrical power cable (2 nos. of 160mm dia HDPE pipe) at Km 132/180 by HDD method in the connection with Railway electrification of Pollachi - Podanur railway section in the limits of national highways for a total length of 60m by M/s. L&T Constructions Limited submitted to this office by the PD, NHAI, Coimbatore vide letter No. NHAI/PIU-CBE/NH-209/L&T/UGEC/132/2021/253 dated 24.02.2021.
2. The available width of ROW is 30m.
3. M/s. L&T Constructions Limited has informed the PD that laying of underground 22 kv electrical power cable (2 Nos of 160mm dia HDPE pipe by HDD Method.
4. M/s. L&T Constructions Limited has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency. Further, the applicant has furnished undertaking that they will adopt HDD method wherever, the available width of ROW is less than 15m.
5. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by M/s. L&T Constructions Limited will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
