### Invitation of Public Comments

Sub: NHAI, RO, Chennai PIU, Salem - Request for permission to lay Underground Optical Fiber Cable (OFC) on NH-7 along the road from Km 185/800 to Km 186/600 (RHS) and across at Km 185/800 of Thumbipadi - Namakkal section of NH-44 for a total length of 843 meter in the state of Tamil Nadu by M/s. Telesonic Networks Limited, Chennai - **Approval Requested** - Reg.

1. The proposal is regarding permission for laying of underground OFC on NH-7 along the road from Km 185/800 to Km 186/600 (RHS) and across at Km 185/800 of Thumbipadi - Namakkal section of NH-44 for a total length of 843 meter (along NH-800m and across NH 43m (HDD) in the state of Tamil Nadu by M/s. Telesonic Networks Ltd, Chennai submitted to this office by the PD, NHAI, Salem vide letter No. NHAI/PIU-SLM/OFC/NH-7/2021/657 dated 09.05.2021.
2. The available width of ROW is varies from 22.5m to 30.00m (LHS) & 22.50m to 30.00m (RHS).
3. M/s. Telesonic Networks Limited, Chennai has submitted undertaking that they will be laying the OFC cable by open trench method along the road and the crossing by HDD Method only.
4. M/s. Telesonic Networks Limited, Chennai has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency. Further, the applicant has furnished undertaking that they will adopt HDD method wherever, the available width of ROW is less than 15m.
5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by M/s. Telesonic Networks Limited, Chennai will be made available for 30 days seeking public
