Sub: NHAI, RO, Chennai - PIU, Coimbatore - Request for permission to lay underground Optical Fibre Cable (OFC) on NH-47 (New NH-544) (Chengapalli - Walayar Section) along the road between Km 133/670 to Km 134/000 (LHS), Km 143/300 to Km 143/800 (LHS) & Km 134/600 to Km 135/000 (RHS) and across @ Km 143/300 for a total length of 1290m in the limits of National Highways by M/s. Jio Digital Fibre Private Limited, Chennai - Approval Requested - Reg.

1. The proposal is regarding permission for laying of Optical Fibre cable on NH-47 (Chengappali - Walayar section) along the road between Km 133/670 to Km 134/000 (LHS), Km 143/300 to Km 143/800 (LHS) & Km 134/600 to Km 135/000 (RHS) and across @ Km 143/300 for a total length of 1290m in the limits of National Highways by M/s. Jio Digital Fibre Private Limited, Chennai submitted to this office by the PD, NHAI, Coimbatore vide letter No. NHAI/PIU-CBE/NH544/OFC/JIO/133-143/2021/686 dated 13.07.2021.

2. M/s. Jio Digital Fibre Private Limited, Chennai has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency. Further, the applicant has furnished undertaking that they will adopt HDD method.

3. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. Jio Digital Fibre Private Limited, Chennai will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
