Invitation of Public Comments

Sub: NHAI, RO, Chennai - PIU, Salem - Request for permission to lay underground Optical Fibre Cable (OFC) on NH-79 (Salem - Ulundurpet Section) along the road between Km 92/600 to Km 92/800 (LHS) and across @ Km 92/800 for a total length of 250m in the limits of National Highways by M/s. Vodafone Idea Telecom Infrastructure Limited, Chennai - **Approval Requested - Reg.**

1. The proposal is regarding permission for laying of Optical Fibre cable on NH-79 (Salem - Ulundurpet section) along the road between Km 92/600 to Km 92/800 (LHS) and across @ Km 92/800 for a total length of 250m in the limits of National Highways by M/s. Vodafone Idea Telecom Infrastructure Limited, Chennai submitted to this office by the PD, NHAI, Salem vide letter No. NHAI/PIU-SLM/OFC/NH-68/2021/1032 dated 14.08.2021.

2. M/s. Vodafone Idea Telecom Infrastructure Limited, Chennai has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency. Further, the applicant has furnished that they will adopt HDD method.

3. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. Vodafone Idea Telecom Infrastructure Limited, Chennai will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
