Sub: NHAI, RO Chennai - PIU - Salem - Request for permission to lay the water pipeline on NH-47 (Salem to Kumarapalayam section) from Km 12/410 to Km 12/505 (LHS) and across the road at Km 12/505 by Open trench & HDD Method by the Executive Engineer, TWAD Board, RWS Division, Salem - Approval Requested - Reg.

1. The subject proposal is requesting permission for laying of pipeline 700mm Dia DI pipe by open trench method from Km 12/410 to Km 12/505 (LHS) and 1219mm dia MS casing pipe across the road by HDD Method at Km 12/505 for total length - ~~1530~~ ^{153 mtrs} in the Project highway of Salem to Kumarapalayam section of NH-47 in the State of Tamil Nadu.

2. M/s. TWAD Board, RWS Division, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. TWAD Board, RWS Division, Salem will be made available for 30 days seeking public comments/objection and shall be furnished within 30 days from the day of closure of public objections.
