

After release of this amount of **Rs.300.00 crore to NHIDCL**, an amount of ₹ 1230 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the EAP works under JICA entrusted to NHIDCL by the Ministry.


