In continuation of this Ministry's sanction letter of even number dated 12th August, 2025, I am directed to convey the sanction of the President to release of fund amounting to Rs.1000 Crore (Rupees one thousand crore only) to National Highways Authority of India for incurring expenditure on the Maintenance and Repairs works of the National Highways under the jurisdiction of NHAI, during the Financial Year 2025-26.

2. The above expenditure is debitable to the following head under Demand No.86 of the Ministry of Road Transport & Highways for the year 2025-26:-

- 3054- - Roads & Bridges (Major Head)
- 01 - National Highways
- 01.337 - Road Works (Minor Head)
- 01 - Maintenance by Road Wing
- 01.02 - Maintenance by Roads Wing Financed from CRIF
- 01.02.29 - Repair and Maintenance

3. There is total BE outlay of ₹ 4555.00 crore under Maintenance and Repairs Scheme for the financial year 2025-26. An amount of Rs.280 crore has been allocated/released to NHIDCL, Rs.250 crore to BRO and Rs.883.89 crore to State PWD, after released of Rs.1000 crore (total:Rs.2400 crore) to NHAI, Rs 741.11 crore shall be in reserve/balance in the head of account.

4. The claims would be entertained as per revised procedure vide this Ministry's letter No. RW/G-20011/2/2001-W&A dated 12.4.2001.

5. The amount should be spent for the schemes sanctioned under the head indicated in para 2 only. No expenditure should be booked/ incurred above the financial limit prescribed in each sanctioned job.

6. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA".

7. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.

8. This issues with the concurrence of Finance Wing vide their Note No.#62 dated 19.9.2025.

9. The Section Officer (W&A Section) will be Drawing & Disbursing Officer in connection with the amount sanctioned above. **An amount of ₹1000.00 crore only (Rupees one thousand crore only)** may be credited in RBI E-Kuber CNA Account **No.10698001007 - Maintenance of NHs to NHAI** through electronic transfer.
