2. The sanction of the President is also conveyed to admit expenditure against sanctioned works under GNHCP Scheme on purely first come first served basis henceforth during 2023-24 out of the **total overall outlay of Rs. 2,152.00 crore under GNHCP Scheme [including Rs. 1,113.00 Crore under Loan Part and Rs. 1,039.00 crore under Counter Part of GNHCP Scheme]** for States/UTs; subject to the condition that office of Principal CCA shall ensure that overall expenditure for sanctioned works under Loan Part and Counter Part of GNHCP Scheme is not exceeded at any point of time, as these would ensure that bills pertaining to well performing States/UTs are cleared without any delay and there is no gestation period involved on account of the requirement to enhance their outlay at any stage in case the States/UTs allocation is/are fully exhausted, as long as the total outlay funded under Loan Part and Counter Part of GNHCP Scheme for States/UTs for entire Country is not fully exhausted.
