In continuation of this Ministry's letter of even number dated 9th June, 2025, I am directed to convey the sanction of the President to allocate and release of funds of Rs.60.00 crore (Rupees sixty crore only) to National Highways & Infrastructure Development Corporation Ltd.(NHIDCL) for EAP works under JICA Counter Part entrusted to NHIDCL during the Financial Year 2025-26 as detailed below:-

3. The total BE provision under EAP JICA Counterpart for the financial year 2025-26 is ₹ 440.00 crore. An amount of Rs.35 crore has been allocated/released to NHAI and Rs.5.00 crore to State PWD. After release of the instant amount of **Rs.60.00 crore [Total: Rs.240 crore] to NHIDCL**, an amount of ₹160 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the EAP works under JICA entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Limited (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.




