Out of which ₹ 20 crore has been allocated to States, ₹90 crore has been released to NHAI and ₹ 410.00 crore has already been released to NHIDCL. After release of this amount of ₹50.00 crore to NHIDCL (total ₹460.00 cr), Nil amount is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the EAP works under JICA entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Limited (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

6. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.
