In continuation of this Ministry's sanction letter of even number dated 26th September, 2024, I am directed to convey the sanction of the President to allocate and release the fund of ₹ 2,014.00 Crore (Rupees Two Thousand Fourteen Crore only) for **Pending Liabilities under Bharatmala Priyोजना under Tribal Sub Plan (TSP)** to National Highways Authority of India (NHAI) during the Financial Year 2024-25 as detailed below.

2. The above expenditure is debit to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2023-24:-

- 5054 - Capital Outlay on Road & Bridges (Major Head)
- 01 - National Highways (Sub - Major Head)
- 01.796 - Tribal Area Sub Plan (Minor Head)
- 05 - National Highways works - Pending liabilities under Bharatmala Priyोजना - Tribal Sub Plan - Works under Road Wing/State PWDs/ NHIDCL/BRO
- 05.00.73 - Infrastructural Assets

3. There is total fund provision (at RE stage) of ₹ 11,489 Crore under "National Highways works - Pending liabilities under Bharatmala Priyोजना - TSP - GBS" head for the financial year 2024-25, out of which ₹ 850 Crore has been released to NHIDCL and Rs.10,639 Crore (including instant proposal) has been allocated for NHAI. After release of this amount, ₹ NIL will be in reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.

6. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

7. This issues with the concurrence of Finance Wing's Note No. 146 dated 05.03.2025.

8. The Section Officer (W&A Section) shall be Drawing & Disbursing Officer in connection with the amount sanctioned above. **An amount of ₹ 2,014.00 Crore (Rupees Two Thousand Fourteen Crore only)** may be credited in RBI E-Kuber Account No.10698001008 of CS - NHAI - Works under Road Works through electronic transfer.


