In continuation of this Ministry's sanction letter of even number dated 7<sup>th</sup> April, 2025, I am directed to convey the sanction of the President to release of fund amounting to Rs.6,000 Crore (Rupees six thousand crore only) to National Highways Authority of India for investment under Major Head 5054(2<sup>nd</sup> Quarter release) for the F. Y. 2025-26.

3. There is total BE provision of ₹ 61,392.37 crore under NH(O)-General (from GBS) for the financial year 2025-26. Out of which Rs.19,775 crore has been allotted for States/UTs, Rs.18.95 crore to M/o Shipping and Rs.900 crore has been allotted to NHIDCL. After release of this amount of Rs.6000 crore [total: Rs.12,400 crore] to NHAI, an amount of ₹ 28,298.42 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured."




