In continuation of this Ministry's letter of even number dated 16<sup>th</sup> July, 2025, I am directed to convey the sanction of the President to the placement of allocation of funds as indicated in enclosed Annexure to States/UTs/PIUs for incurring expenditure on the National Highways (Original) [NH(O)] works including committed liabilities under Bharatmala Pariyojna being executed through State / UT PWDs / RCDs / MoRTH PIUs / BRO during the Financial Year 2025-26.

2. Allocation at this stage have been made only for those States/UTs/PIUs in respect of whom demands have been received.

3. The claims would be entertained as per revised procedure vide this Ministry's letter No. RW/G- 20011/2/2001-W&A dated 12.4.2001.

4. While entertaining the claims on the basis of allocation referred to above, it may please be ensure that:-

- (i) Expenditure is incurred only on sanctioned works on National Highways only,
- (ii) No claim is entertained for expenditure incurred on any sanctioned works in excess of the sanctioned cost beyond permissible limits'
- (iii) No expenditure is admitted on work/portion of the work where it might have been specifically advised not to incur any expenditure pending receipt/approval of certain issues/points, etc.

5. This issues with the concurrence of Finance Wing vide their Note No. #128 dated 4.8.2025.

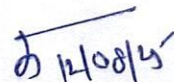
