In continuation of this Ministry's letter of even number dated 16.01.2023, 15.12.2022 and 14.11.2022, I am directed to convey the sanction of the President to allow ROs/RPAOs to admit expenditure against sanctioned OR(N), OR(C), FDR(N), FDR(C) and OR(DPP) works on purely First-come-First-serve basis henceforth during Financial Year 2022-23 out of the total overall allocation as given in Col.(4) of the following table under OR(N), OR(C), FDR(N), FDR(C) and OR(DPP) (3054.01.337.01.02.27) for States/UTs/PIUs, subject to the condition that office of Principal CCA shall ensure that overall expenditure for OR(N), OR(C), FDR(N), FDR(C) and OR(DPP) separately not exceeded at any point of time as these would ensure that bills pertaining to well performing States are cleared without any delay and there is no gestation period involved on account of the requirement to enhance their outlay at any stage in case the States/UTs allocation is/are fully exhausted as long as the total outlay funded for States/UTs for entire Country is not fully exhausted.
