2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2022-23:-

3. There is total RE provision of ₹ 8,626.20 crore under NH(O)-NE (from GBS) for the financial year 2023-24. Out of which, an amount of ₹1100.00 crore has been allocated to States/UTs and ₹5,000.00 crore has been released to NHIDCL. After release of this amount of ₹ 400.00 crore to NHAI (total ₹2526.20 crore), Nil amount is reserve/balance in the head of account NH(O)-NE.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.

5. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
