I am also directed to convey the sanction of the President to allow ROs/RPAOs to admit expenditure against sanctioned LWE Non-TSP works on purely first come first served basis henceforth during 2022-23 out of the total overall allocation of ₹ 32.00 crore for the States/UTs; subject to the condition that office of Principal CCA shall ensure that overall expenditure for LWE Non-TSP is not exceeded at any point of time as these would ensure that bills pertaining to well performing States are cleared without any delay and there is no gestation period involved on account of the requirement to enhance their outlay at any stage in case the States/UTs allocation is/are fully exhausted as long as the total outlay funded by LWE Non-TSP for States/UTs for entire Country is not fully exhausted.
- 3. The expenditure is debitable to the above head under Demand No. 86 Ministry of Road Transport & Highways for the year 2022-23.
- 4. The works under LWE schemes are to be implemented on the pattern of National Highway Works and Direct Payment Procedure as being adopted for NH works.
