Subject: Mechanism for compensation of Revenue Loss on account of delayed fee revisionreg.

Sir,

This is in reference to the proposal received from NHAI vide File No. CODIV-14/8/2025-CO Division (M/o RT&H C. No. 255710) regarding the modality for compensation to the affected concessionaire for revenue loss arising from deferment of revision in annual fee rates for the Financial Year 2024-25.

2. The proposal has been examined in this Ministry. In this regard, it is conveyed that the Competent Authority has agreed to and approved the proposal as received from NHAI, granting extension of the concession period to the affected concessionaires as compensation for the delay in revision of annual fee rates for the Financial Year 2024-25. The finalized mechanism is as follows:

## Mechanism for revision of Concession Period:

Increase in Concession Period (days) = [A]
[B]

## Where:

A= Total revenue difference for 63 days (i.e. 01.04.2024 to 02.06.2024, difference between revenue after and before revision of fee rates)

- B = Revised Collection per day (i.e. Collection from 01.04.2024 to 02.06.2024 on revised fee rates/63 days)
- 3. Nevertheless, it may also be noted that revision of user fee does not violate the Model Code of Conduct (MCC), as the statutory provisions for such revision apply uniformly from a specific date, i.e. the commencement of each financial year. Accordingly, to avoid any linking with the MCC, such revision should be notified well in advance, keeping in view that the dates of the Elections in any State are known beforehand. This may be complied with in future to avoid recurrence of such circumstances.
- 4. This may be brought to the notice of all concerned for further necessary action in the matter.

5. This issues with the concurrence of Finance wing vide Note#32 dated 16.11.2025 and approval of Hon'ble Minister RT&H.
