I am directed to convey the sanction of the President of India to the release of funds to the tune of Rs. 73.93 Crores (Rupees Seventy Three Crore and Ninety Three Lakhs only) to the State of Madhya Pradesh out of Central Road Infrastructure Fund for the financial year 2020-21. This is the 03rd Instalment being released during the year 2020-21.

2. These funds should be used for the projects approved under the Central Road Fund (State Roads) Rules, 2014 published vide GSR No. 531-E dated 24th July, 2014.
3. For the funds to be utilized under the on-going old CRIF schemes, the State Govt. of Madhya Pradesh is requested to ensure the funding pattern laid down in the relevant sanction letters of the Ministry.
4. The State Govt. of Madhya Pradesh will be required to furnish the utilization certificate in accordance with Rule 8 of the CRF Rules, 2014 in Form along with quarterly progress report and monthly Expenditure Statement, as per Form-II & III respectively of the Rules *ibid*.
5. Principal CCA's Office is authorized to issue necessary credit advice for this payment.
6. Utilization Certificate has been received checked & found to be in order and kept in record.
7. The State Govt. of Madhya Pradesh has submitted the certificate of job completion and installation of display boards on roads for CRIF works.
8. The State Govt. of Madhya Pradesh is also required to furnish the completion reports/certificate duly verified by the Audit as and when the work is completed.
9. The expenditure is debitable to the Major Head-3601 (Plan) Grants-in-Aid to State Governments(MH); 08-Other Transfer/Grants to States (Sub-Major Head); 08.108- Grants from Central Road Fund (Minor Head); 01-Grants for State Roads; 01.00.35 - Grant for creation of Capital Assets - corresponding to Demand No. 84 of the Ministry of Road Transport & Highways for the year 2020-2021.
10. This sanction issues with the concurrence of Finance Wing vide Note # 324 dated 05.11.2020.


