Sir,

In continuation of this Ministry's sanction letter of even number dated 26th September, 2025, I am directed to convey the sanction of the President to release of fund amounting to Rs.30,315 Crore (Rupees thirty thousand three hundred and fifteen crore only) to National Highways Authority of India (NHAI) for investment under Major Head 5054 (4th Installment) for the F. Y. 2025-26.

2. The above expenditure is debitable to:

- 5054 - Capital Outlay on Roads & Bridges (Major Head)

 - 01.190 - Investment in Public Sector & Other Undertakings (Minor Head)
 - 01 - National Highways Authority of India
 - 01.00 - National Highways Authority of India
 - 01.00.54- Investment
- in Demand 86 of the Ministry of Road Transport and Highways for the year 2025-26.

3. There is a BE Provision of Rs.1,22,266 Crore under this Head. Out of this an amount of Rs.1466 crore has been allocated to States for NHDP-IV works. After this release of this sanction amount of Rs.30,315 crore to NHAI (total: Rs.1,20,666 crore), Rs.134 crore shall be in reserve/balance in the head of account.

4. The Section Officer (W&A) of the Ministry will be the Drawing and Disbursing Officer for the payment of this amount. Amount of Rs.30,315 crore (Rupees thirty thousand three hundred and fifteen crore only) may be credited into RBI E-Kuber CNA account of CS-NHAI-10698001001 - National Highways Authority of India.

5. NHAI should submit the utilization certificate to MoRTH and follow the Rules as contained in 149(iii), iv, 150, 150(5) and 151 (2) of GFR.


