I am directed to say that it has been decided with the approval of the competent authority to admit and make release of fund under CRF during 2017-2018 (till 31/3/18) to concerned States on first come first served basis so long as release for the state does not exceed the accrual for States(as per col.6 of Annexure) and available unspent balance of State (as per col.3 of Annexure).

Further, the State-wise release of fund on first come first serve basis may be allowed upto the limit of maximum possible release for individual State as per col.7 of Annexure. However, the total sum of release for all States shall not exceed the total accrual for States for 2017-2018, i.e upto Rs.7036.13 crore
