Subject: Release of funds to States/UTs under EI&ISC for the current financial year 2014-15 –regarding.

Sir,

In continuation of this Ministry's letter of even number dated 25/11/2014(copy enclosed) on the subject mentioned above, I am directed to say that as per revised Central Road Fund Rules, 2014, Direct Payment Procedure (DPP) will be applicable for payment under the scheme EI and ISC.

2. Your Office has stated that Direct payment procedure cannot be applied for payment under EI and ISC under the existing Head of account and a new head been suggested for the purpose. Action has been taken by Budget Section to open a new head with the approval of Ministry of Finance as suggested by your Office. It may take time to open a new head and then re-appropriation of fund under the new Head. No payment is being released under the scheme after coming into force the new CRF Rules. Funds under the schemes will be lapsed if the funds are not released timely to State Governments.

3. Keeping in view the above position, it is requested to continue the earlier procedure for release of fund under the scheme EI and ISC for the current financial year 2014-15 and DPP may be implemented w.e.f. the next financial year after availability of appropriate Head for the purpose.

4. This issues with the concurrence of Finance Wing vide their U.O. 4023/TF-II/2014-15 dated 13/02/2015.

Sub: Approval of Projects under Centrally Sponsored Schemes of Economic Importance (EI) and Inter State Connectivity (ISC) schemes for 2013-14-reg

Sir,

I am directed to refer to Central Road Fund (State Roads) Rules, 2007 for prescribing the rules for the disbursement of the Central Road Fund in respect of specified projects, schemes and activities relating to development and maintenance of State roads including roads of Economic Importance and Inter-State Connectivity (EI&ISC).

2. It is requested that the proposals for the roads works under EI&ISC schemes for the year 2013-14 may be submitted in order of priority for consideration, along with the details given below:-

- (i) name of the work and district(s);
- (ii) a state road map showing the proposed road/bridge works and indicating district boundaries, National Highways, State Highways, major district roads, rural roads or other types of roads in different colours, in addition to the roads already approved under the scheme and on-going works under this schemes;
- (iii) index map showing the area and the proposed road or bridge works;
- (iv) category of the road proposed to be improved whether the State highway or major district road or otherwise;
- (v) scope of the work including the specifications to be adopted in brief;
- (vi) length;
- (vii) estimated cost of the project based on the actual requirement and realistic cost estimate along with an abstract of cost estimate;
- (viii) justification of the work for inclusion in the scheme;
- (ix) details of last improvement work done on this road and the calendar year in which it was carried out;
- (x) probable starting date;
- (xi) target date of completion;
- (xii) a certificate regarding availability of the entire unencumbered land needed for the project.

Proposals submitted in absence of any of the above details will not be considered for approval.

3. The State Government may ensure that any proposals involving land acquisition and/or shifting of utilities is not included in the list forwarded to this ministry for consideration. The proposal of state roads other than rural roads (Other District Roads and Village Roads) will only be considered.

4. Ministry based on availability of funds, existing liabilities and priority of schemes, will select schemes and issue Administrative Approval. The State/UT Government will submit detailed estimate to the Ministry for Technical & Financial Sanction for selected schemes. In case estimated cost of the detailed proposal exceeds 10% of the administrative approval, fresh administrative approval is to be solicited from the Ministry. As such due care to be taken while indicating cost of the proposal for administrative approval.

5. As far as allocation of funds under EI&ISC is concerned, State-wise allocations will not be made. However, releases will be made based on UCs received from the State/UTs. Accordingly, it is requested to furnish the details of anticipated requirements and submit the UCs immediately for enabling further necessary action.

6. All the proposals for consideration should be forwarded in one list only instead of sending proposals separately. All such proposals should be addressed to the Chief Engineer (Planning) of this Ministry. Proposals received beyond 30th April, 2013 will not be considered.


