In continuation of this Ministry's sanction letter of even number dated 18<sup>th</sup> September, 2025, I am directed to convey the sanction of the President to release of fund amounting to Rs.6,300 Crore (Rupees six thousand three hundred crore only) to National Highways Authority of India for investment under Major Head 5054 for the F. Y. 2025-26 as detailed below .

2. The above expenditure is debitable to the following head under Demand No.86 - Ministry of Road Transport & Highways for the year 2025-26:-

3. There is total BE provision of ₹ 61,392.37 crore under NH(O)-General (from GBS) for the financial year 2025-26. Out of which Rs.34,462 crore has been allotted for States/UTs, Rs.18.95 crore to M/o Shipping, Rs.30.70 crore to M/o Railway/Govt of Bihar and Rs.1250 crore has been allotted to NHIDCL. After release of this amount of Rs.6,300 crore[total: Rs.24,700 crore] to NHAI, an amount of ₹ 930.72 crore is reserve/balance in the head of account.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.

5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured.”.





6. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.

7. This issues with the concurrence of Finance Wing's Note No.#242 dated 26.12.2025.

8. The Section Officer (W&A Section) will be Drawing & Disbursing Officer in connection with the amount sanctioned above. **An amount of ₹ 6300.00 crore (Rupees six thousand three hundred crore only) may be credited in RBI E-Kuber CAN A/c No. 10698001008 of CS-NHAI - Works under Road Wing through electronic transfer.**
