- 3. There is total BE provision of ₹ 61,392.37 crore under NH(O)-General (from GBS) for the financial year 2025-26. Out of which Rs.34,462 crore has been allotted for States/UTs, Rs.18.95 crore to M/o Shipping, Rs.30.70 crore to M/o Railway/Govt of Bihar and Rs.1250 crore has been allotted to NHIDCL. After release of this amount of Rs.6,300 crore[total: Rs.24,700 crore) to NHAI, an amount of ₹ 930.72 crore is reserve/balance in the head of account.
- 4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHAI by the Ministry.
- 5. Compliance of the provisions of OM (F.No.12(13)-B(W&M)/2020) dated 25.05.2022 issued by Budget Division, Department of Economic Affairs, Ministry of Finance, has been ensured."



- 6. The accounts of National Highways Authority of India (NHAI) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
- 7. This issues with the concurrence of Finance Wing's Note No.#242 dated 26.12.2025.
- 8. The Section Officer (W&A Section) will be Drawing & Disbursing Officer in connection with the amount sanctioned above.
