Out of total BE allocation of Rs.30,385.14 crore under NH(O)-General for the financial year 2022-23, an amount of Rs.11,312.00 crore has been allocated to States/UTs, Rs. 7050.00 crore to NHAI, Rs.500.00 crore to BRO and including sanction letter, an amount of Rs. 3000.00 crore has been allocated/released to NHIDCL. After release of this amount, an amount of Rs.8,523.14 crore is reserve/balance in the head of account NH(O)-General.

4. It shall be ensured that the expenditure against above sanction is incurred only on the NH works entrusted to NHIDCL by the Ministry.

5. The accounts of National Highways & Infrastructure Development Corporation Ltd. (NHIDCL) shall be open to inspection by the sanctioning authority and audit, both by the C&AG and internal audit by the office of Pr. CCA.
