OFFICE MEMORANDUM

Sub: Approved Sanction Ceiling for NH(O) Works for State/UT PWDs for the FY 2021-22-Reg.

Ref:- M/oRT&H OM No. NH/15017/18/2020-P&M dated 30.03.2021 regarding continuation of spill over sanctions in FY 2021-22

Competent Authority has approved the additional sanction ceiling for NH(O) Works for State/UT PWDs for the FY 2021-22, amounting to Rs. 1,03,708 crore. State-wise additional approved sanction ceiling for State Governments/UTs is at **Annexure**.

2. Sanction ceiling of Rs. 1,000 crore has been separately allowed for the Road safety Zone for taking up road safety works and rectification of black spots during the FY 2021-22.

3. Concerned Project Zones may get the projects sanctioned as per the approved Annual Plan for the FY 2021-22. Monitoring Zone is requested to compile the sanction status on monthly basis and inform the Planning Zone to keep a watch on the total sanctions issued.

4. Project Zones must check that, if the project stretch is totally confined within the tribal district, then such projects should only be got sanctioned under NHO-TSP head.

5. Sanction of works to be executed by State & UT PWDs/ RCDs, etc. / MoRT&H PIUs is allowed subject to the following:-

- i. Sanction of those road widening/ geometric improvements with strengthening and CD / Bridge/ ROB works for which at least 90% land is available and Strengthening works.
- ii. LA and preconstruction activities for other projects and the projects which are to be taken up during 2022-23 and 2023-24; however, decision to sanction and initiate LA and pre-construction activities for such projects shall be based on feasibility / viability of such projects based on their DPR / feasibility reports, EIRR/ FIRR, etc.
- iii. Sanction of Preparation of DPR and other miscellaneous works.
- iv. Sanction of PR / IRQP works shall be conveyed separately. Accordingly it is requested not to take up PR / IRQP works for sanction under Annual Plan.
