  - c. No payment should be made for the works which are not inspected by RO/Project Zone.
  - d. The RO/Project Zone should also check the quality of the work. Necessary instruction may be given to concerned State/ UT in this regard for rectification if any.
  - e. The payments under EI&ISC works should only be made after completely satisfying the progress of work.
  - f. ROs shall also ensure compliance to all observations/ shortfalls.
