- (a) Prior to booking of further expenditure against any work consequent to revised allocation being made, the concerned RO shall inspect the particular work. The RO should satisfy w.r.t the progress of the work.
- (b) No payment should be made for the works which are not inspected by RO.
- (c) The RO should also check the quality of the work. Necessary instruction may be given to concerned State/UT in this regard for rectification, if any.
- (d) The payments under EI&ISC works should only be made after completely satisfying the progress of work.
- (e) ROs shall also ensure compliance to all observations/shortfalls.


