

The receipt of online license fee deposition should be submitted to this office with intimation to the Executive Engineer, NH- Division, Gandhidham. The BG should be in favor of the Executive Engineer, NH- Division, Gandhidham (as per prevailing procedure in R&B Dept.) and to be submitted to Executive Engineer, NH- Division, Gandhidham custodian of BG/s.
