Invitation of public comments

Sub: Proposal for grant of access permission to retail outlet of M/s HPCL at km 29/594.2 to 29/630 ( Khasra no.625) on NH-158 of the Village-Sidiyas, Tehsil-Mandal, Distt-Bhilwara in the State of Rajasthan.

M/s HPCL ie. the applicant vide letter of even no. dated 20.07.2018 has submitted a proposal to this office on above captioned subject. This office has forwarded the proposal to EE PWD NH Div-Pali for site investigation vide this office letter of even no.dated 06.08.2018 and EE PWD NH Div-Pali vide letter 1961 dated 16.11.2018 received in this office dated 22.11.2018 has submitted required report. As per the verified check-list by EE PWD Nh Div Pali, it has been mentioned that there exists intersection at 917 m against 1000m standard measurement. However EE PWD NH Div Pali as verified and recommended the said proposal. Looking into the case regarding the safety of road users and traffic, this office has decided to put the proposal for public comments (if any) according to Ministry Guidelines relaxation policy issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.
