
It is to inform you that the Ministry is in the process of 6<sup>th</sup> revision of Ministry's Specification for Road and Bridge Works (Orange Book) which was last revised in the year 2013. Ministry's Specification for Road and Bridge works forms part of Contract agreement of EPC, HAM and BOT(Toll).

The **Section 100 to Section 900** of aforesaid specifications are modified by IRC in consultation with Ministry. **The copy of the modifications proposed is enclosed as a comparative format wherein proposed modifications are given in comparison with the existing provisions herewith for kind perusal.**

The implementing agencies may also have certain suggestions for modification in various clauses of aforesaid specifications. All such comments /suggestions are to be taken into consideration while revising the Ministry's Specifications. Agencies are having vast experience of implementing projects therefore valuable input is very crucial for modification of specifications.
